History of Arizona's Legal and Legislative Action Leading to SB1014 / Reduced EL Hours

In 1992, parents of students in the Nogales Unified School District filed suit in federal district court alleging the civil rights of English Learners (EL) students were violated under the Equal Education Opportunities Act because Arizona did not have a program that included "adequate language acquisition" or sufficient funding for EL students, and entry and exit procedures were poor.

In 2000, the court ruled in favor of the plaintiffs and the Arizona Department of Education (ADE) entered a consent decree that said:

- Students will be taught English Language Development daily.

- Students who struggle academically will get additional support.
- Standardized assessments will determine placement in English programs.

That same year, voters approved Proposition 203, which mandated that students identified as EL would be educated separately through Structured English Immersion (SEI) programs for no more than a year.

Under Prop. 203, EL students were supposed to remain in these SEI programs for no more than a

year to become proficient in English. But in practice, this hasn't always been the case.

A law enacted in 2006 required every school district to provide a four-hour model of SEI for students who are classified as EL. Critics say the program segregates students who do not speak English as their native language from students who do.

In 2014, the courts determined the state met all the requirements of the 2000 consent decree.

The reclassification rate of students who became proficient in English last year

was about 15 percent, according to the ADE. Students who have tested to become "Reclassified Fluent English Proficient" have not exceeded 31 percent since 2011, according to ADE.

In February, however, Gov. Doug Ducey signed SB1014, which reduces the number of required hours EL students must be taught and gives school districts flexibility to craft their own research-based models. Advocates hope this will help students better learn and improve scores on the AZELLA.

SB 1014 Gives Arizona LEAs and Teachers of EL Greater Flexibility

Senate Bill (SB) 1014 was signed into law, giving public schools and teachers of English Learner (EL) students more flexibility to develop instructional models that best fit the needs of their communities.

SB 1014, which passed the Legislature with unanimous support and was signed by the Governor in February 2019, eliminates the rigid four-hour state-mandated block of English-language instruction and instead allows public schools and teachers to develop their own research-based models based on the needs of their individual students. SB 1014 requires only an average of two hours of English learning per day.

Researchers and advocates of the bill indicated that the four-hour English mandate caused students to miss out on relevant subject matter in other fields like math, science, and history.

While SB 1014 provides flexibility to LEAs to develop their own research-based models, these models must be approved by the State Board of Education to ensure that the models align to Arizona's English language proficiency standards and include oral and written language in a structured environment for at least 2 hours a day that is inclusive of reading, writing, and comprehension strategies with integration of grade-level content.

SB 1014 also removes some of the burdensome reporting requirements for public schools and directs ADE to collect data and analyze the effectiveness of all approved models to identify best practices that can be shared among public LEAs and educators.
